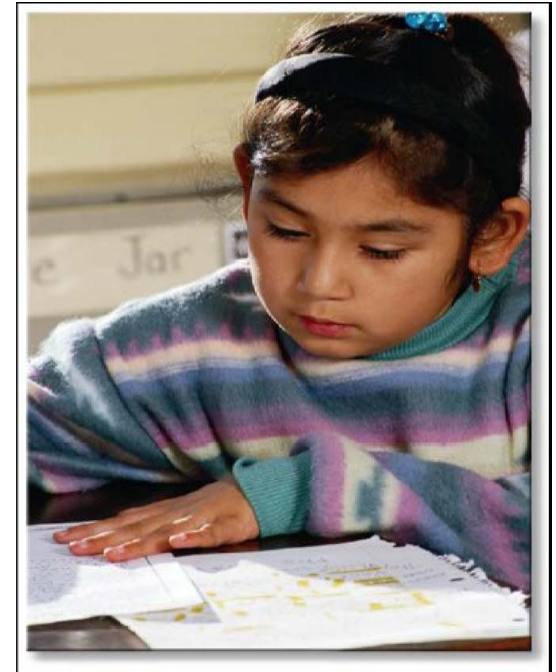

### **Qhov Wisconsin Student Assessment System (WSAS) yog dab tsi?**

Qhov Wisconsin Student Assessment System (WSAS) yog ib qho kev xeeb uas qhia tau rau peb hais tias txhua tus me nyuam kawm tau ntawv zoo li cas raws li cov Wisconsin Model Academic Standards. Qhov Wisconsin Knowledge and Concepts Examination (WKCE) yog ib qho feem ntawm WSAS.

Qhov WSAS kuj muaj ib qho kev xeeb txawv rau cov me nyuam uas kawm ntawv nyuaj zog vim lawv kawm tau ntawv qeeb zog (WAA-SwD). Yog xav paub ntxiv txog ntawm daim WAA-SwD, thov saib daim WAA-SwD Me Nyuam/Niam Txiv Ntawv Nyeem Npaj Ua Ntej Xeeb, nyob rau hauv <http://dpi.wi.gov/oea/publications.html>.

Nyob rau hauv lub xeeb Wisconsin, tag nrho cov me nyuam kawv chav 3-8 thiab 10 tau xeeb cov ntawm no.

### **Cov ntawv xeeb rau Wisconsin Knowledge thiab Concepts Examination no yog dab tsi?**

Txhua lo lus nug nyob hauv qhov ntawv xeeb no yeej yog tej uas lawv tsim tawm rau txhua tus me nyuam kawv ntawv hauv teb chaws mekas no thiab muaj qee lo lus nug kuj yog tshwj xeeb rau cov me nyuam kawv ntawv hauv Wisconsin no xwb. Qhov WKCE rau cov kawm chav 4, 8, thiab 10 muaj xeeb raws li no, nyeem ntawv thiab ua lej, muaj tej lo lus nug thiab muaj ob peb qhov uas yus mam xaiv saib qhaub twg thiaj thwj, thiab sau tej kab lus me me. Qhov WKCE rau cov nyob chav 4, 8, thiab 10 muaj ob peb qhov kev xeeb ntxiv thiab. Xws li uas kev sau ntawv kawm txog kev nom tswv nyob teb chaws no, kawv txog lub ntiab teb, thiab kev sau ntawv.

### **Kev xeeb no pab tau li cas?**

Cov qhab nees ntawm kev xeeb WKCE no qhia tau niam txiv txog ntawm me nyuam txoj kev kawm. Yuav kom paub meej tshaj ntawm tus me nyuam txoj kev kawm, yuav tsum tau saib txog nws txoj kev kawm hauv nws lub chav kawm ntawv, qhab nees rau lwm yam ntawv xeeb, tej ntawv ua tom tsev, thiab lwm yam uas nws kawm txog. Thov nrog cov xib fwb thiab cov neeg pab tawm tswv yim sib tham txog ntawm WKCE. Seb yuav siv tau li cas nrog lub tsev kawm ntawv thiab nws chav kawm ntawv kom pab tau nws kawm tau raw li nws lub hom phiaj kawm ntawv. Tuam tsev kawm ntawv yuav siv cov qhab nees no koj los pab kho cov program kawm ntawv.

Cov qhab nees ntawm kev xeeb WKCE no pab tau rau lub koom haum Department of Public Instruction lawv ntsuam xyuas kom

- Paub tias cov tsev kawm ntawv twg yog cov uas kawm tsis tau ntawv zoo raws li txoj cai nyob rau lub xeeb Wisconsin uas yog s.115.38(4);
- Kom paub tias txhua tus me nyuam kawm tau ntawv raws li txoj cai No Child Left Behind (NCLB) Act uas pib tawm xyoo 2001 uas yog kom siv tej yam ntawv uas zoo tshaj xwb koj los xeeb cov me nyuam kom paub meej tias lawv kawm tau ntawv li cas;
- Kom txhua tus me nyuam kawm tau ntawv raws li txoj cai Title I (NCLB) uas hais kom txhua lub tsev kawm ntawv uas muaj qhov Title I program no teev tseg saib cov me nyuam kawm chav no kawm tau zoo li cas;
- Qhia tau rau lawv paub tias lub tsev kawm ntawv twg thiab lub zog twg thiaj li muaj cov tsev kawm ntawv uas qhia tau ntawv raws li txoj cai kev kawm nyob rau lub xeeb Wisconsin no.

### **Cov qhab nees uas yuav muab no zoo li cas thiab yog dab tsi?**

Qhov WKCE no qhia tau txog seb koj tus me nyuam paub thiab ua tau li cas raws li cov Wisconsin Model Academic Standards. Cov qhab nees uas cov me nyuam tau ces yog raws li lawv ua tau thaum xeeb. Kev ua tau zoo yog tswm tawm los ntawm ib phab uas saib kev kawm ntawv nyob rau Wisconsin.

- Advanced (Qib Siab) – To taub tob txog ntawm cov ntsiaj lus uas lawv xeeb hauv WKCE
- Proficient (Txawj txaus) – To taub zoo txog ntawm cov ntsiaj lus uas lawv xeeb hauv WKCE
- Basic (Paub tseem tsawv) – To taub me ntsis txog ntawm cov ntsiaj lus uas lawv xeeb hauv WKCE
- Minimal Performance (Paub me me xwb) – To taub tsawg txog ntawm cov ntsiaj lus uas lawv xeeb hauv WKCE

### **Lub sij hawm twg yog lub sij hawm yuav xeeb ntawv?**

Kev xeeb WKCE rau lub xyoo 2011-2012 no yuav pib lub 10 hli hnuv tim 24 mus txog lub 11 hli hnuv tim 25 xyoo 2011. Kev xeeb no siv sij hawm ntawm 3 ½ teev thiab 15 feeb mus rau 6 ½ teev. Kev xeeb tej zaum yuav siv sij hawm nto li ob peb hnuv. Ib lub tsev kawm

ntawv twg nws mam li teem nws lub caij xeeb. Yog koj tus me nyuam tsis tuaj lub sij hawm lawv xeeb ntawd, nws yog ib qho tseem ceeb heev ua nej yuav tau teem sij hawm rau nws xeeb kom tag.

### **Saib Cov Ntawv Xeeb WKCE**
