## **Assessment**

#### Reminder:

#### **Verify Student Data**

DPI will load student data from WISEdata into the DRC INSIGHT Portal (Forward) and PearsonAccess (ACT with writing and PreACT Secure). To ensure that you have the correct roster of students for testing, please make certain that your student enrollment and demographic data are correct in WISEdata before the end of the day on January 25.

# **ACCESS for ELLs**

#### New:

#### **Test Window Closing**

The ACCESS for ELLs test window will close on Friday, February 2. Please ensure that all students have completed all sections of the assessment by the end of that school day.

The last day to order Additional Materials is January 26. All materials are due back to DRC on or before Tuesday, February 13. Please ensure that UPS picks up your materials by Friday, February 9 to meet this deadline.



# **ACT**

#### New:

**ACT Accommodations - Due January 19** 

The last day to request ACT Accommodations and EL Supports is January 19. This is a firm deadline.

Accommodations requests submitted after this date will not be approved unless a unique circumstance warrants a <u>Qualified Exception to Deadline</u>. Resources on how to enter accommodations can be found on the Wisconsin ACT Website, Step 3 - Accommodation.

#### **Online Testing Site Readiness Service**

On January 15, ACT will begin their outreach to schools and districts who opted into ACT's Online Testing Site Readiness Service. DACs should continue to monitor emails and calls from this service.

# **PreACT Secure**

#### New:

#### PearsonAccessnext Opens January 22

On January 22, the PreACT Secure portal will open within <u>PearsonAccess</u> (PAnext) for the spring 2024 administration. Once the portal is open, DACs will automatically have access through the assessment drop down menu using their existing PAnext account credentials. DACs will need to create accounts and grant user access to the PreACT Secure portal for all testing staff. Instructions on how to create accounts and/or update existing accounts can be found in the PersonAccess User Guide for the PreACT Secure.

Please make sure that all Test Administrators and students have been added and updated in Educator Portal. In order for teachers to complete the first contact surveys, students need to be rostered to the teachers. Please also confirm users are up to date and that any users that do not require access are removed. If you have any questions about rosters and users, please contact Mike Peacy.

#### **Training**

In order for a teacher to be able to administer the DLM they need to complete the required teacher training. Teachers who are new to DLM or did not complete training last year need to complete the new teacher training. Returning teachers who completed the training last year need to complete the returning teacher training this year. Please encourage teachers to complete the training as soon as possible.

### **NAEP Assessment Planning Tasks**

NAEP School Coordinators should be working through the Assessment Planning Tasks in the <u>NAEP Assessment Management System (AMS)</u>. Registered School Coordinators received an email from westatstudies.com notifying them of the tasks, and the tasks will be reviewed during the Assessment Planning Meeting scheduled with the NAEP field staff. DACs can review the progress of most of the tasks in the NAEP AMS, but will not have full access to all the tasks unless they are also designated as the School Coordinator.

#### NAEP High School Transcript Study Open Through January 31

The NAEP High School Transcript Study (HSTS) data collection is open in the <u>NAEP Assessment</u> <u>Management System (AMS)</u>. HSTS Coordinators will complete the course catalog submission and the transcript information survey, which are open through the **end of January**. The last step of the HSTS is the student transcript submission which will open in the summer of 2024.
