2022-23 Assessment Data Public Release

Spring 2022-23 statewide assessment results for the Forward Exam, ACT, PreACT Secure, and DLM were released today. A press release is available on the <u>DPI News Releases webpage</u> and performance data from these assessments are available in the <u>WISEdash public portal</u>. 2022-23 Preliminary Secure Report Cards - October 16 Deadline to Open an InquirySecure preliminary versions of the 2022-23 School and District Report Cards are available in <u>SAFE</u>, the Secure Access File Exchange. As a preliminary and secure report, they contain potentially identifiable student information, and have not been redacted. As such, and because the report cards are preliminary and subject to change, the secure reports and any information on the preliminary report cards may not

be shared with your local media, parents, or members of the community.

The inquiry period closed on October 16th and OEA will be working with schools and districts to resolve open inquiries.

The public release of final school and district report cards is scheduled for **November 14**. These report cards will include redaction to protect student privacy. At that time the public school and district report cards results will be widely available.

Deadline to Register for 2024 In-Person Training

The October 20 registration deadline for the in-person Forward Exam 2024 DAC Training is quickly approaching. Identical trainings will be held in different locations across the state November 6-10 from 9:00 am to noon each day. District Assessment Coordinators (DACs) and up to three assessment staff members (e.g., School Assessment Coordinator, Assistant to DAC) should register as soon as possible. Staff selected to attend do not need to attend the training at the same location. **An email with registration information was sent to all DACs on September 14.** Registration must be completed no later than **October 20**.
