# **Accountability**

#### New:

#### Report Cards: Final Secure and Scheduled Public Release


Earlier today, district and choice school administrators received an <u>email</u> from Deputy State Superintendent John Johnson announcing that **final secure school and district report cards are available** in <u>SAFE</u>, the Secure Access File Exchange. Please note that the data in these final secure report cards are non-redacted and should **not** be shared publicly. **The public release of 2022-23 report cards is scheduled for November 14.** If you have questions about report cards, please <u>contact OEA</u>.

#### Data for 2023-24 Accountability Being Captured December 5

The <u>WISEdata Student Snapshot</u> scheduled for **December 5** will capture data to be used throughout 2023-24 School and District Report Cards and ESSA and IDEA accountability systems. The snapshot will capture the following data used in accountability:

- 2022-23 attendance, discipline, high school completion, course and program participation
- 2023-24 Third Friday of September Enrollment including economic disadvantaged status
- 2023-24 October 1 Child Count of students with disabilities (for IDEA)
- All student demographics

**Please check for data alerts in WISEdata Portal.** Data quality alerts signal that data differ substantially from prior years or are being submitted with errors. Alerts are indicated in the orange panel at the top of the WISEdata Portal page (see screenshot below). Click the blue Learn More button to review the specific alerts for your school or district.

## **ACCESS for ELLs**

#### New:

#### Finalize Tech, Training

ACCESS testing begins on December 4. Please double-check that all staff who will be administering ACCESS have completed the necessary training(s) they will need in order to administer the assessment(s) they will be in charge of. Training is in the WIDA Secure Portal, and you may view training completion under Manage > Certification Report.

Now is also the time to finalize and check DRC Insight installs on student devices. You may also wish to designate time for students to take the practice tests, available within Insight. In particular, young students can often benefit from practicing using the microphone on Speaking, and students with disabilities should have experience with any accommodations they will be receiving on the test.

Test setup is open, and you may manage test sessions as needed, set accommodations, adjust demographics, and add any students missed during the October upload window.

#### **Materials Delivery**

On November 28, materials will be delivered to the district based on the rosters uploaded in October. Please plan to inventory your materials and distribute them to schools as needed. At this time, Additional materials may be ordered through the WIDA AMS portal, and they will be delivered in about two business days.

#### **Selecting Staff for ACT Testing**

DACs and Test Coordinators should carefully review the Staff Requirements and Staff Roles and Responsibility sections of the <u>ACT Test Coordinator Information Manual</u> (p. 16) when selecting staff for ACT testing roles. Staff who have relatives testing and athletic coaches are restricted in what testing roles and responsibilities they can be assigned to.

#### 2024 PAnext Portal

The 2024 <u>ACT PearsonAccess (PAnext) portal</u> opened on November 6. DACs received access to the portal, along with instructions on how to set up testing staff within PAnext and select an ACT testing date, at that time.
