## Assessment

### New:

#### Statewide Assessment Windows Close This Week

We would like to thank everyone for administering the spring Statewide Assessments. Your attention to detail helps to ensure all students have the opportunity to demonstrate their knowledge and skills. We appreciate you and the time and effort you put into assessing our students.

### Reminder:

#### Test Participation

Statewide assessments are required by state and federal law. Participation of all enrolled students ensures the validity of test results used for state and federal accountability determinations, public reporting, and continuous improvement. We ask that you make it a priority to regularly monitor testing progress and schedule testing to ensure all students are tested during the test window dates.

## Accountability

### New:

#### Final Joint Federal Notifications

As announced in [an email to District Administrators from Associate Deputy State Superintendent Tom McCarthy](#), final joint federal notifications (JFN) were provided to schools and districts in [SAFE, the Secure Access File Exchange](#), on April 23. The JFN packet includes final:

- ESSA Accountability Reports
- ESSA Progress to Exit Reports
- IDEA LEA Determinations
- IDEA Racial Equity in Special Education Reports
- District Summary Report

## ACCESS for ELLs

### New:

#### Post-Reporting Data Validation Window

A final post-reporting data validation window will be open from May 7 - 21. This is the last chance to correct any irregularities in student reports. Any changes made during this window will be reflected in updated electronic reports available on June 5. As a reminder, data will be available in the DRC Insight portal April 26, and paper score reports will be delivered on May 10.

## ACT

### New:

#### ACT Test Administration

Spring 2024 ACT testing has concluded. Please ensure that all materials have been sent back to ACT, test sessions are stopped, and test content purged from caching computers.

#### Entering Not Tested Codes

Students who did not take the ACT during any of the three testing windows will need to be marked as “not tested” in PAnext. Please follow the instructions outlined in the [ACT Administration Supplement - Entering Not Tested Codes](#) to complete this process. If you have a large number of Not Tested Codes to enter, you can upload them using the Student Registration Export. Review the [DPI April 3 ACT program email](#) for instructions. Deadline to enter Not Tested Codes is April 26.

#### ACT Standard Setting - Deadline to Apply May 1

DPI is recruiting a diverse group of Wisconsin educators to establish cut scores for the ACT in English Language Arts (ELA), Mathematics and Science. This event will take place in Madison July 10-11, 2024. This is a great opportunity to be a part of DPI’s assessment work, have detailed input on the ACT, and take knowledge back to your district about the process. ## PreACT Secure

### New:

#### Final Testing Week

This is the final week of PreACT Secure testing. Any 9th and 10th grade students who have not completed testing will need to test this week. Testing concludes on **April 26**.

## PreACT Secure Scores

On May 1, PreACT Secure scores will begin to post in [Success](#). Student scores will continue to post throughout May with all scores and data being finalized on May 30. **No paper Individual Student Reports (ISRs) will be sent to schools. Schools will be responsible for downloading and disseminating ISRs to families.** DPI encourages schools to wait until all data is final before downloading and distributing ISRs. Instructions on how to access and download ISRs will be communicated in the upcoming weeks.

## Reminder:

### Post Testing Reminders

Once testing is complete:

- Complete all test administration forms for each testing room and collect materials (online and paper testing).
- Ensure all test sessions have been stopped. If testing has been completed and sessions are showing “In-Progress,” remove all students who did not test (Ready status) and “Mark Complete” students who have completed testing. Do not mark not-tested students as complete.
- Enter any test irregularity reports into PearsonAccess<sup>next</sup> (paper and online testing). [Online Administration Manual](#) (p. 39).
- Prepare and return all **paper accommodated secure materials** to ACT (p. 31 of [Test Coordinator Manual](#)). Deadline **May 10**.
- Purge cached test content from all servers on **April 26**.
- Enter Not-Tested Codes. **Deadline May 3**.

**Note: Do not return any online testing materials to ACT. Retain onsite for one year then securely destroy.**

## DLM

### New:

#### DLM Test Window Coming to a Close

The DLM test window closes on **April 26**. Please complete all testing by this Friday. DACs are encouraged to log into Educator Portal and download a *DLM Test Administration Monitoring Report* to identify students who still need to complete testlets. Directions on how to use the Report function can be found in the [Educator Portal User Guide](#).

#### Rater Forms

Students who have been rostered to Social Studies need to have a completed rater form. The rater forms can be found on the [DLM Resources webpage](#). Rater forms need to be completed and entered into Educator Portal by the end of the day on **April 26**.



### Collection of Student Writing Samples for Dynamic Learning Maps Alternate Assessments

Please submit student writing samples from the Writing Testlet to DLM. Writing samples can be submitted through [Educator Portal](#). Samples will be used to support evidence of the quality of the assessment system and inform future assessment development. Please upload any writing samples by **April 26**.

#### Test Administration Observations

## Forward Exam

### New:

#### Forward Exam Test Window Closes April 26

The Forward Exam test window closes on April 26. All students enrolled in grades 3-8 and 10 during the test window are expected to participate in the Forward Exam (or DLM) and will be included when determining the district and school test participation rates. Please complete all make-up testing by this Friday.

#### Forward Exam 10th Grade Social Studies

This is an important reminder to ensure your 10th grade students participate in the Forward Social Studies Exam. All testing must be completed by April 26.

#### Forward Exam Not-Tested Codes

District Assessment Coordinators (DACs) must enter a Not-Tested Code (NTC) in the DRC INSIGHT Portal for all students who were unable to be tested or who participated in the DLM. The deadline to enter Not-Tested Codes is May 3, **this deadline cannot be extended**. Students must be in a test session in order to view, assign, or edit their NTC. Information on assigning NTCs is available on p. 32 of the [DRC INSIGHT Portal Guide](#).

#### Tasks that Must be Completed Prior to the End of the Testing Window

Prior to the end of the window all districts should:

- Utilize the Student Status Dashboard (see p. 41 of the [DRC INSIGHT Portal Guide](#)) in the DRC INSIGHT Portal to monitor testing progress for each school and identify students that still need to complete test sessions.
- Check student demographic data for completeness and accuracy. Reporting in the DRC INSIGHT Portal and on Individual Student Reports (ISRs) will be based on student demographics as they are



found in the DRC INSIGHT Portal. Accountability and WISEdash reporting will be based primarily on student data submitted to DPI through the WISEdata system.

### Option to Decline Paper ISRs

All districts currently receive the Individual Student Reports (ISRs) in the following formats:

- One master PDF with all students, in all grades, in all schools, in the district (sorted by grade, then school).
- Separate PDFs for each school and grade in the district (multiple files, one for each school and grade)
- New for this year – all districts will receive Individual Student Reports (ISRs) provided in a zipped folder. This format allows for easier upload of the electronic ISRs to a student information system (SIS) or secure parent portal.
- Two paper copies (one for the student file and the other one to be shared with the parent/guardian).

Districts now have the option to decline the paper ISRs by having their DAC complete and submit the [2024 Forward Exam Request to Decline Paper Individual Student Reports \(ISRs\) Form](#) by June 28. Districts are still required to provide parents/guardians with a complete ISR in either a secure electronic version or paper version.
