Balance of State CoC Overview

The BOS is a 501(c)3 organization that serves as the CoC for 69 of Wisconsin's 72 counties (all except Dane, Milwaukee and Racine) The mission of the organization is to end homelessness by supporting local coalitions throughout Wisconsin.


The BOS is comprised of 21 local coalitions. Each make up a "member" of the organization.

"Ending homelessness" means every community will have a systematic response in place that ensures homelessness is prevented whenever possible, or if it can't be prevented, it is a rare, brief, and non-recurring experience.











Congress appropriated \$145 million to HUD for these rounds of YHDP



Competition was available to all 400+ CoCs in the nation



WI BOS is 1 of 33 CoCs in the nation engaging in this work



WI BOS is joined by 46 YHDP communities from Rounds 1, 2, 3

YHDP In Action

Youth Action Board (YAB)

- Active local/regional YAB in 11 areas with ongoing recruitment
- Each have opportunity to select someone to represent their local group on the CoC-wide YAB
- CoC-wide YAB meets every Wednesday evening (virtual)
- All youth receive compensation (\$15/hour, mileage, supplies):
 - ✓ Local/regional YAB = through 12/2023
- ✓ CoC wide YAB = ongoing
- All plans & projects required YAB approval
- Authentic youth voice & leadership

Coordinated Community Plan (CCP)

- Balance of State's plan was submitted to HUD and approved.

Goals

- (1) Stable Housing Youth and young adults are immediately WIBOSCOC provided with safe, supported, and flexible housing options that reflect their individual needs and pave the way for long term, sustainable housing
- Permanent Connections Youth and young adults are supported in cultivating consistent, self-identified people who can respectfully guide, support and advocate with them to get their needs met;
- (3) Education and Employment Youth and young adults have access to educational resources to achieve their career goals, helping to prevent homelessness for at-risk youth and young adults and create sustainable pathways to income and housing for youth and young adults experiencing homelessness;
- (4) **Social and Emotional Wellbeing** The health and well-being of youth and young adults are prioritized by meeting youth where they are and providing them with the resources and supports they need to achieve happiness, health, self-sufficiency, and self-actualization.
- (5) Systems Change Increase cross-system coordination and collaboration with a commitment to authentic youth voice.



Projects

YHDP funding can serve at-risk or unaccompanied youth and pregnant and parenting youth who are:

- Under age 25
- Meet criteria of HUD's definition of homeless
 - Category 1 = Literally homeless unsheltered, emergency shelter
 - Category 2 = imminently lose housing (14 days)
 lease, doubled up, couch surfing, hotel
 - Category 3* = unaccompanied youth & homeless families, other federal definition *Requires HUD approval, no community has achieved this yet
 - Category 4 = fleeing or attempting to flee violence or other life threatening conditions

Goal is to make youth homelessness RARE, BRIEF, and ONE TIME

- To achieve rare = front porch services
 - ✓ outreach,
 - ✓ diversion,
 - ✓ navigation
- To achieve brief = crisis services
 - ✓ crisis housing
 - ✓ Kinship care
- To achieve one time = permanent housing
 - ✓ joint transitional-rapid rehousing,
 - ✓ Rapid re-housing,
 - ✓ Permanent supportive housing

Balance of State CoC will sub-contract with an agency in each of the 17 YHDP participating coalitions to hire a system navigator to:

Provide a single point of contact within each local coalition for youth to help with navigating complex systems in addition to housing needs

Collaborate with education, law enforcement, juvenile justice systems, foster care services, and social service providers (e.g., health care, SNAPS, workforce programs) to connect youth to the coordinated prevention and diversion resources.

Support community partners meet the needs of youth and serve as a safe and supportive resource for those not presenting in the existing homeless service system.

Support and facilitate the local youth action group to ensure that authentic youth voice continues and become integrated into decision-making within the local coalition.

Collaboration Opportunities

Our CoC meets quarterly to provide training, speakers, big picture discussion, and business meetings.

- Open invitation for attendance
- Opportunities to present to larger membership
- Chance to run as a board member and serve on committees
- Collaboration with local & statewide providers
- Participate in system change, advocacy, & policy change with CoC
- Provide financial support to large scale initiatives (such as the System Navigator)

Each of the 21 local continua have meetings to discuss and problem solve how to end homelessness.

- Difference between direct service staff and decision makers
- Gather feedback directly from local providers
- Participate in funding allocation conversations at the local level
- Work with individual projects to provide joint case management & participate on teams
- Join the team to end youth homelessness at local level

Work with the Statewide Homeless Management Information System (<u>HMIS</u>)

- Data collected is used in advocacy, gaps and needs analysis, funding prioritization, and additional collaboration opportunities.
- Enter into data-sharing agreement between agency & Institute for Community Alliances (WI HMIS lead)

Participate in <u>Coordinated</u> <u>Entry</u> as a referring entity

- Join the "no wrong door" system
- Options to complete a prescreen form, assessment, referral, and conduct follow-up
- Help inform local decision makers of the need in the community by making connections
