Error 7094

- **SHORT TEXT:** Non-primary coursework enrollment exists but primary enrollment is missing.
- **LONG TEXT:** Coursework and demographics for this student will not be reported. Your school has submitted a non-primary enrollment with the enrollment type of coursework. No primary enrollment exists for this student. Verify the non-primary enrollment status. If correct, work with the School District responsible for providing primary education services; that district must submit a primary enrollment for this student.

Comparing WISEdata to WISEdash

Things to consider when comparing WISEdata to WISEdash:

- WISEdata is updated from WISEdash every night
- Specific errors in WISEdata will stop student data from passing through
- Snapshots are taken from WISEdash so verification of that data is VITAL

Primary and Non-Primary Enrollments

- School of attendance is Primary.
- Parent Placed Private students may have a Primary & non-Primary enrollment.
- Coursework students always have a Primary & non-Primary enrollment.
- Coursework non-Primary enrollments should include only roster information.

Coursework Non-Primary Enrollments

- Coursework non-Primary enrollments should include only roster information.
- Attendance, discipline, credential, and program data from the non-Primary school must be communicated to and submitted to WISEdata by the school of Primary enrollment.

Coursework Non-Primary Enrollments

When do you use Coursework enrollment?

- Student takes classes at more than one school in your district
- Student from another public district takes class(es) at your district

Coursework Non-Primary Enrollments

When do you NOT use Coursework enrollment?

- Student from a private school takes class(es) at your district -
DON'T NEED TO REPORT
- Student being home schooled takes class(es) at your district -
DON'T NEED TO REPORT

Error 7094

The error could throw if:

- You submitted a Coursework enrollment, but the primary district has not yet submitted their enrollment. The error will clear when they submit the primary enrollment.
- You submitted a Coursework enrollment, but you haven't yet submitted the primary enrollment. The error will clear when you submit the primary enrollment.
- You submitted a Coursework enrollment when you shouldn't have (for a private school or home school student, for example).
- You accidentally submitted the wrong non-Primary enrollment type (you intended it to be PPP, for example).

Error 6396

- **SHORT TEXT:** The first name OR last name OR suffix of the student does not match the value in WISEid.
- **LONG TEXT:** The first name OR last name OR suffix supplied to WISEdata does not match the equivalent data properties for this student in WISEid. Middle name is not considered for this rule. Review WISEid and your local SIS and make necessary corrections.

Error 6396

- This error will throw when the first name or last name or suffix sent to WISEdata does not match any name for this student in WISEid.
- Middle name is not considered for this rule.
- Error should throw only for the agency or agencies that can edit the data.
- The correction can be made either on the WISEid side or the WISEdata side, whichever is appropriate.
- Sometimes it's okay to leave the error!

EX: Student's name changes in Dec. 2020, WISEid and WISEdata are updated for 2020-21, but 6396 throws in 2019-20

Error 6766

- **SHORT TEXT:** This 'Section' is associated to 'Zero' student Section Associations.
- **LONG TEXT:** This 'Section' is associated to 'Zero' student Section Associations. Please submit student School Associations for the section if present or DPI recommends districts to clean up the section data.

Warning 6769

Enrollment exists for the student, but student has 'Zero' student Section Associations.



Error 6719

- **SHORT TEXT:** Exit Type, 'Transfer to another school covered by WISEdata; known to be continuing' (TC), should be used, as DPI has evidence of subsequent enrollment.
- **LONG TEXT:** Exit Type, 'Transfer to another school covered by WISEdata; known to be continuing' (TC), should be used, as DPI has evidence of subsequent enrollment. This student has a more recent WISEdata enrollment period, but the Exit Withdrawal Type submitted was some value, known to be continuing, other than TC. The Exit Type should be submitted as TC.

Error 6719

- When a subsequent WISEdata enrollment exists prior to TFS of the next school year, your exit type code must be TC.
- The error often throws when a student leaves your district as TOS, TNC, etc., then enrolls in another Wisconsin district or choice school.
- Some SIS vendors allow behind-the-scenes mapping, allowing you to code the student the way you want in your SIS but still send the correct TC exit type to WISEdata.

Warning 6374

- **SHORT TEXT:** This enrollment period overlaps another enrollment period or is totally encompassed within another enrollment period. This enrollment is invalid. The enrollment must either be removed or revised such that it is not overlapping with or entirely encompassed within another enrollment period.
- **LONG TEXT:** For submission to DPI, agencies must reconcile entry and exit dates such that no overlap is submitted to DPI. DPI is aware that overlap does occur. In such cases all agencies involved shall cooperate with the following rules prior to submission. This enrollment period overlaps with or is totally encompassed within another enrollment period. This enrollment is invalid. The enrollment must either be removed or revised such that it is not overlapping with or entirely encompassed within another enrollment period.

Warning 6374

- When students transfer out of a public or choice school, the exit data is not always sent.
- Resolving the overlap when there is no exit date associated is frustrating for you!
- When the exit date is NULL it is also difficult for WISEdata. It is not easy to program validation logic to determine which school is at fault.
- 6374 was previously an error but was changed to a warning to hopefully make it easier for districts and schools.

Warning 6374

- This warning throws when there are multiple enrollments with at least one of them submitted with an enroll or exit date causing the enrollments to overlap.
- Enrollments cannot overlap, not even for one day.
- Check to make sure you have entered your enroll and exit dates correctly.
- If your dates are correct, contact the other district or school to work out a resolution.
- If you have difficulty connecting with the other district or school, feel free to open a help ticket.

Warning 6374

Remember:

- The exit withdraw date is whichever comes first:
 - The date before transfer to another school, i.e. the last date in a seat at school.
 - The date on which a student graduated.
 - The date official evidence is received or documented that the student left the school
 - The date a student died.
- For continuing students, the exit date is the last day of attendance for the school year.

Warning 6374

Remember:

- If the agencies cannot resolve the overlapping enrollments, DPI effective date logic will implement enrollment start and end dates that remove overlapping enrollments.
- If both schools/ districts are claiming that a student was present on Third Friday of September (TFS) and are unwilling to change the exit date and/or enrollment date, the error will remain in WISEdata Portal for both schools/ districts. WISEdash for Districts by default will count the student as TFS eligible for the school/ district in which the student is currently enrolled.

Error 7139

Ed Env Invalid for Age

- **Short Text:** Invalid Educational Environment Setting based on student age and grade level for the effective period of the special education record. This error can throw in 5 different scenarios, so read the detail in the error 'Long Text' carefully and/or click the KBA article link for more information.

Error 7139

Ed Env Invalid for Age

- **Long Text:** Invalid Educational Environment Setting based on student age and grade level for the effective period of the special education record. Educational Environment Setting codes are defined for two age groups: Preschool (Age 3 to 5 not in KG) and School age (Age 5 in KG to 21. If the child is age 5 and the grade is KG or higher, the school-age educational environment categories will be used. If the child is age 5 and the grade is K3, K4, or PK, the preschool educational environment categories will be used. If the child is age 3-4 then the preschool educational environment categories should be used. If the child is age 5 in KG -21 then the school age ed env categories should be used. To ensure accurate federal reporting, it is critical that the sSEPA that covers October 1 has a valid educational environment for the student age as of October 1.

Error 7139

The error is thrown in the following (four) situations:

- 1) Student is age 3 or 4 on the SSEPA end date and the ed env code is submitted as school age, then you get the error. To fix the error change the education env code to preschool.
- 2) Student is age 5 on the SSEPA end date, grade level is < KG, and the ed env code is submitted as school age, then you get the error. To fix the error change the education env code to preschool.
- 3) Student is greater than or equal to age 5 on the SSEPA end date, grade level is > = KG, and the ed env code is submitted as preschool, then you get the error. To fix the error change the education env code to school age.

Error 7139

4) Student is age 5 on begin date and grade level <kG and age 6 on the end date. In this case, separate the SSEPA record for age 5 and age 6. On the SSEPA record where the student is age 5 on SSEPA end date and grade level is < KG and the correct education env code is preschool. An error will be thrown if any other ed env code is used. On the SSEPA record where the student is age 6 on SSEPA end date irrespective of grade level, the education env code is school-age

Error 7139

- The error often throws when a 5 year old in K4 turns 6 before June 30, which is the end of the DPI school year. (Scenario #4 above.)
- If your vendor allows, you can end the sSEPA record (on your district's last day of school, for example), which would clear the error. Many vendors do not allow for this, however.
- If the sSEPA and enrollment cannot be ended then you have to “live with” the error.
- The DPI WISEdata team is reviewing this and other validations to try to find a way to better handle “future date” scenarios.

Error 6795

- **SHORT TEXT:** Certificated Program Status type not submitted for certified program when a program is not associated to course.
- **LONG TEXT:** Certificated Program Status type not submitted for certified program when a program is not associated to course. To correct this error, submit the certificated program status type.



Error 6795

The error throws when the Certified Program Status field is null, and the Program is not associated with a course.

Error 6795

To clear the error:

- Submit the correct Certified Program Status value (most likely).
- OR
- Associate the Program with a course (probably less likely).

Error 6795

Submitting Certified Career Education Programs:

- For Certificated Program Status Type, the certification status for 'Certified Career Education Programs' which are not associated to courses should be submitted as part of the program association.
- For example, if a student is participating in a nursing certificate, but if this certificate program is not associated to a course in the student's schedule, then the certification status for the program should be submitted in this field.
- Depending on the status, one of the program area types should be submitted.

Error 6795

Certificated Programs Status Type

Code	Short Description	Description
A	Completed with Certificate	Student met the requirements of the certificated program and was or is to be awarded a certificate
B	Continuing	Student is continuing in the certificated program
C	Exited	Student has left the certificated program before completion
D	Completed without Certificate	Student completed program but did not meet the requirements for the certificate

EL Related Validations

Some common errors and warnings:

- Error 6379: ELP Code is missing. This field is required for all students.
- Warning 6781: The ELP Code of 7 indicates the student was never EL, but the student took the ACCESS for ELLs test in the immediately prior school year.
- Warning 6782: The Native Language is set to English when the student is not English Language Proficient (e.g., the student's ELP code is between 1 and 5). A Native Language other than English is expected.
- Error 6638: ELL Served is not expected for proficient students. ELL Served was provided, but ELP Code is '6', '7', or blank.

Error 6777


- **SHORT TEXT:** The SEOA ELP Code does not align to the ACCESS for ELLs Overall Composite Proficiency Level from the immediately prior school year. The Overall Composite Proficiency Level is between 1.0 and 4.4, but the ELP Code does not equal the digit to the left of the decimal of the Overall Composite Proficiency Level.
- **LONG TEXT:** The SEOA ELP Code does not align to the ACCESS for ELLs Overall Composite Proficiency Level from the immediately prior school year. The Overall Composite Proficiency Level is between 1.0 and 4.4, but the ELP Code does not equal the digit to the left of the decimal of the Overall Composite Proficiency Level. The Overall Composite Proficiency Level is determined by the prior year administration of the DPI-approved ACCESS for ELLs test, regardless of which district, local educational agency, or Choice school in which the test was administered. Correct the ELP Code in your SIS to match the truncated ACCESS for ELLs Overall Composite Proficiency Level from the immediately prior school year.
